Mail your original responses and a the date-stamped copy of the Verification and Certificate of Service to the opposing party's attorney, or to the Defendant if he/she is representing themselves.

• It is recommended you send discovery to the opposing party via United States Certified Mail, return receipt requested. However, you can send it via regular First Class mail.
